Schisandra berry is one of the few new species of medicinal plants introduced to the official use as a pharmacopoeia species in the European medicine (including Poland) only a few years ago. Schisandra berry is used as a plant **boosting the general psychophysical condition in humans**. Primarily, it helps **reduce stress and tension, supports the functioning of the nervous system and calmness**. The most important components of the Schisandra berry fruit are lignans, including **schisandrins**. These compounds show **hepatoprotective, adaptogenic and antioxidant effects**^{1,2}. Strong **adaptogenic properties** of Schisandra berry fruits stand out in particular. The term adaptogen refers to a substance allowing the body to react to physical, chemical and biological stress agents, by increasing a non-specific body response to a given stressor. An adaptogen increases the body's ability to adapt to changing conditions in its environment.

As an adaptogen, schisandra berry helps the body adjust to ever-changing environmental conditions³. One of the biggest problems faced by contemporary man is stress and work under pressure that, when present for a prolonged time, have negative effect on a human body. Besides the deterioration of health, they also lead to decreased life satisfaction. Schisandra berry **helps reduce this tension and eases fatigue** resulting from constant emotional stimuli and stressful job. As an **antioxidant** with protective properties on body cells, as well as a plant with properties **fostering the minimisation of inflammatory processes**, schisandra berry supports also **the functioning of the immune system** and helps activate it to fight pathogens.

Schisandra berry is also helpful during cold and helps ease the emerging symptoms⁴⁻⁶.

Polysaccharides found in *Schisandra chinensis* foster the maintenance of the **optimal level of neurotransmitters in the central nervous system**, thus indirectly contributing to the **improved ability to learn and memorise**. Indirectly, **they also improve alertness, foster the improvement of concentration and mental performance without nervousness and irritation**¹. Schisandra berry fruit extract shows also the effect **that fosters the**

maintenance of optimal mood and functioning of the cholinergic system, which is responsible for cognitive function, memory, and concentration⁷. What's more, the effect of lignans found in *Schisandra chinensis* on the **shortened fatigue and a boost in resilience** was proven based on clinical trials^{1,8}.

The DUOLIFE Schisandra Berry food supplement also contains acacia fibre, which synergistically supports the action of the main ingredient - Schisandra berry fruit extract.

Acacia fibre

Acacia fibre found in the DUOLIFE Schisandra Berry food supplement is a natural bulking agent with valuable properties. Acacia fibre is sourced from acacia trees growing in Africa; it belongs to the soluble fibre fraction and supports the health-oriented effect of Schisandra berry. Moreover, fibre is included in the group of the so-called prebiotics stimulating the growth of natural intestinal microflora. It also fosters optimal functioning of the digestive tract. It helps intestinal peristalsis, has a positive impact on the so-called gut-brain axis, contributing to supporting the functioning of both the gastrointestinal and central nervous systems⁹.
